Written notice of an objection must first be given to the auditor and a copy sent to the smaller authority. 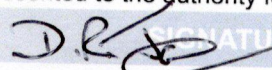

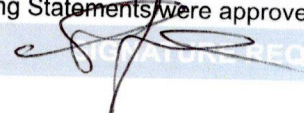
